## Legal regulations:

- WAZ, Law on Abortion ,1984
- Abortion is still in the criminal law, up till now
- Up to 24 weeks Amenorrhoea, also by foetal impairmant,

- From 1-1-2023 there is **no** mandatory reflection period anymore. It was 5 days from visiting a doctor until the treatment.
- Decision must be well-considered en voluntary.
- It should be an emergency situation considered by the woman.
- Age limits: > 16 treated as an adult
  - >12 and < 16, the doctor decides if she is competent to decide
  - < 12, permission is necessary of parents or legal guardian.









- 16 out-patient clinics (92% in 2022), 89 hospitals (8% in 2022).
- In the clinics the providers are Medical Doctors, GP, Gyn. There education is on the spot.

- In the hospitals Abortions are performed by Gynaecologists.
- From 1-1-2025? Medical abortion also through GP.





### Methods:

- In 2022: 37% medical abortion versus 63% surgical.
- Medical abortion allowed up to 9 weeks Amen.
- In the hospitals the second trimester abortions (> 13 weeks ) medical .
- In the clinics surgical abortion > 9 weeks.

#### **Financing**

Non profit

Women living in the Netherlands with BSN and a health insurance for free. Paid by the government.

Others have to pay.

The government sets the amount of the reimbursement.

#### Exceptions,

Immigrants with a COA number

Woman from Ukraine are paid by the governement

# Abortion in Germany



## Legal Regulations:



Since 1933 the law is in force (the law in former east German was more liberal):

Abortion is still in the criminal law, art. 218.

Up to 14 weeks Amenorrhoea (the gyn. all say it's allowed up to 12 weeks, but that is gestational weeks), by foetal impaiment >

It is mandatory to go to attend counseling agencies recognized by the country. They differ in background.

Then there is a mandatory waiting period of 3 days in between counseling and treatmant.

Exception for abortion after prenatal diagnoses and minors < 14 years. These are not covered by this law.



#### **Providers**

- Few clinics around the country. Most are performed by gynaecologists in a private practice.
- Since juli 2022 art. 219a has been crossed out. It forbid docters to announce that they perform abortions. It did not have much effect.
- Abortions are performed by gynaecologists and non- gyn. But to settle with assurance you need a gynaecologist, at least op paper,





### Methods:

- Medical abortion is allowed up to 9 weeks Amenorrhoea
- About 41 % of the abortions is performed by medical abortion.
- Surgical abortion is performed by curettage with curettes or by aspiration.
- Second trimester abortion is raraly available, even up to 14 weeks

 Abortion after prenatal counseling and < 14 years is not considered as an abortion in the statistics.



#### Costs:

- Women have to go to the health insurance company to check for financial backup.
- If their income is below a certain limit their abortion is on government costs.
- If not they have to pay. Each 'Bundesland' has their own standards.
- Amount of payment is little and takes a long time. Some times up to one year.



## Legal regulations versus practical consequences

#### The netherlands

- Up to 24 weeks AM
- Criminal law
- Costs paid for all women who have a dutch insurence.
- 504-1372 euros
- No mandatory counseling and waiting days
- 65% < 8 weeks AM
- 31% medical abortion

#### Germany

- Up to 14 weeks AM
- Criminal law
- Costs paid for a certain group
- 221,23 -306,96( medical)
- Mandatory counseling, 3 waiting days. And a lot of forced waiting days by gynaecologist.
- 45% < 8 weeks Am</li>
- 46% medical abortion (lack of providers for surgical abortion.)
